Subject: Non-Districted Land Representative(s) Process Recommendations

Summary:

The KNDLA Joint Powers Agreement (JPA) section 4.1 requires the Board of Directors include “two representatives for owners of Non-Districted Land.” The JPA requires appointment “following recommendation(s) from Members or owners of Non-Districted Land.” However, the JPA does not otherwise provide a process for obtaining recommendations or appointing Non-Districted Representatives (NDR). This ad hoc committee examined different options for outreach, recommendations / nominations, voting, term limits, vacancy and removal.

Recommendations:

Outreach:

- Post solicitation for NDR recommendations on the KNDLA website with link to NDR recommendation / nomination form.
- Develop map outlining the white area (completed).
 - Give directions on the KNDLA website to assist landowners with APN lookup.

Recommendations / Nominations

- Submission of completed recommendation / nomination form (attached)
 - Submission: email Rachelle / or admin email
 - Eligibility: Must own land or represent landowner in KNDLA jurisdiction
 - Closure: Nov. 18, 2024 (the Monday prior to the Nov. meeting)

Voting:

[Standard two vote option]

Each voting KNDLA board member shall vote for two recommended candidates; the candidates with the most votes and second most votes will be appointed. The two votes may not be cast for a single candidate, only one vote per voting Board member may be cast for each candidate. In the case of a tie for the most votes, both candidates will be appointed. In the case of a tie for the second most votes, the KNDLA board shall take another vote between these two candidates, with each voting member casting a single vote. The candidate with the most votes for this second vote shall be appointed.

Term Definition and Limits:

- Each appointment will be for a term of two years, there will be no limit to the number of these two-year terms.

Vacancy:

- Vacancies will be filled by the same nomination and approval process set forth above.

Removal:

- Appointed representatives may be removed by a 75% affirmative vote on a noticed motion.
